#### Target Broadleaf Weeds, Application Rate, and Use Restrictions:

**Note:** Some minor leaf cupping may occur. Do not use if unwilling to accept minor leaf injury.

#### Broadcast Applications

Apply uniformly with ground equipment in 20 to 75 gallons of water per acre.

**Spring Application:** If needed, make a ground application in the spring no later than 30 days prior to harvest at 1/3 pint per acre.

**Post-Harvest Application:** Refer to the Perennial Strawberries section of the Stinger package label for post-harvest application instructions.

**Spot Applications:** Refer to the Hand-Held Sprayers section of the label for Stinger for spot application instructions.

#### Recommendations:

- For difficult to control weeds, best results will be achieved with a post-harvest application followed by a spring application.

- If newly planted, **do not** make an application in spring directly after planting; instead, make a post-harvest application that year (per direction on the Stinger package label) and, if needed, a spring application the following year.
